The bank account of the branch is re-registered together with the capital to the new owner on the basis of the sales contract of the branch. The new owner of the branch automatically acquires the rights of an authorized reseller of branches (conditions in Package 4).

Package 3. The branch does not contain capital in the form of money on its balance sheet, but it contains leads that have already been paid for at 100% of their value with a conversion rate of 99% - (Lead is one of the main elements of CRM. A lead is an unqualified sales opportunity. A lead can be a company or an individual who has expressed interest in a company's product and/or service. In a CRM system, a lead is usually the starting point of a person's record). And leads with a 99% conversion rate we offer ensure almost 100% sales for each lead. That is, you can choose branch with leads that can bring a net profit of 100 thousand euros or 500 thousand euros or 1 million euros or 3 million euros or 5 million euros or 10 million euros.
